## **EXHIBITOR CONDITIONS OF ENTRY**

- 1. All information given on this form should be complete and correct at the time of entry. This entry covers the exhibitor named only no refunds will be made.
- 2. ECP&DA (the Organisers) reserve the right to refuse any entry to the Rally without giving any reason.
- 3. Third party insurance must be held for a minimum of £1,000,000.
- 4. You accept that you are responsible for the conduct of all members of your team (i.e. those people that this entry covers overleaf), including any children and pets at all times and in all places. Please keep dogs on a lead at all times and do not allow dogs to foul the Rally site or towpath.
- 5. All Exhibitors must comply with the Organisers and Site Officers' instructions; Our decision as to the allocation of pitches, which may change without notice, and other arrangements is final. You agree not to change the space allocated to you in any way without the agreement of the Site Manager. You also agree that no part of your stand will extend beyond the agreed boundary of your pitch without the agreement of the Site Manager.
- 6. Setup must be complete before the event opens each day and no early closing or dismantling of stands is permitted without the express approval of the Site Manager. The organisers cannot accept any responsibility for your goods if you leave your pitch unattended. You are advised not to leave equipment or goods on site overnight.
- 7. You agree not to leave any litter on the Rally site, towpath or cause pollution to the surrounding area.
- 8. You agree not to store any equipment on the towpath or adjacent to it, and not to cause nuisance to others, whether by excessive noise or any other activity.
- 9. The organisers will not be held responsible for any damage or loss, other than that for which we are legally liable as a result of our negligence. We will not be liable for any loss due to events beyond our reasonable control. We will not be liable for any loss due to early closure, late opening, or failure to open the event.
